

REGULAR MEETING COMMON COUNCIL – May 27, 2025

The Common Council of the City of Huntington met on the 27th day of May 2025, at 7:00 p.m., in accordance with all applicable requirements and notice.

INVOCATION: Rev Chris Lantz, Evangelical United Methodist Church, gave the invocation.

CALL TO ORDER: Mayor Strick called the regular meeting of the Common Council to order.

ROLL CALL: Common Council Members present: Dwight Brautigam, Charles Chapman, PJ Felton, Dave Funk, Todd Johnson, Paul Pike, and Andrew Rensberger.

PUBLIC HEARING: Mayor Strick opened the public hearing concerning [Ordinance 10-C-25](#), an alley vacation at Huntington Mobile Estates. With no one wishing to speak, Mayor Strick closed the public hearing.

APPROVAL OF PREVIOUS MINUTES: Council Member Johnson moved to approve Council's May 13, 2025, regular meeting minutes as presented, seconded by Council Member Chapman. Motion passed 7-0. Minutes signed.
