# ORDINANCE NO 2006-/0 AN ORDINANCE TO AMENDING THE HUNTINGTON COUNTY ZONING ORDINANCE (Ponds)

WHEREAS, it is in the best interest of the Huntington Community as a whole to amend the Huntington County Zoning Ordinance regarding <u>SECTION 1040</u>: Ponds; and

WHEREAS, the proposed amendment to <u>SECTION 1040: Ponds</u> better serve the citizens of Huntington County by improving the review process for proposed ponds with respect to setback requirements; and

WHEREAS, The Huntington County Plan Commission considered Docket PC-06-004, a petition to amend the text of the Zoning Ordinance. A record of the petition and Plan Commission action recommending a **favorable recommendation** of the Zoning Ordinance text amendment is attached hereto and incorporated by reference as "Exhibit A".

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Huntington County, Indiana that the Zoning Ordinance of Huntington County be, and is hereby, amended to by adding language to <u>SECTION 1040: Ponds</u> as set forth in the following exhibit:

### **HUNTINGTON COUNTY POND ORDINANCE**

#### G: Variance Procedure:

- 1. Variance from the minimum requirements of this section shall be filed in accordance with procedures set forth in Section 6.3 of the "Rules and Procedures of the County BZA" or the variance from the minimum requirements of this section shall be unanimously agreed to in the field (at the pond site) in writing by all of the following (A) A representative of the Department of Community Development (B) A representative of the County Surveyors Office (C) A representative of the County Highway Department (D) A representative of the landowner for the pond site (E) A representative of the adjoining landowner if and only if the variance is along an adjoining landowners tract.
- 2. If all of the above mentioned representatives listed in (A), (B), (C) & (D) do not unanimously concur on the variance (along with the representative of (E) if necessary [see above]), then a request for a variance from the minimum setback requirements or alteration of the direction of volume of water flow from the property shall be submitted to the Department of Community Development. A filing fee of sixty dollars (\$60.00) shall be paid to the Department.
- 3. A letter from the County Surveyor stating the Surveyor's recommendation on the proposed variance request shall be filed with the application.
- 4. Inspections The Huntington County Surveyor's Office shall be notified by the property owner and/or excavation contractor when work commences on the construction of a pond to insure compliance with the requirements set forth in this section.
- 5. If any tiles are cut, broken down, or rendered less effective during development activity on a lot, the landowner shall be responsible for the repair, replacement, or relocation of the tile on the lot to maintain the amount of drainage through the lot that existed prior to the development act.
