

**ORDINANCE NO. 2008 -10**

**ORDINANCE ESTABLISHING UNIFORM  
FEE SCHEDULE FOR HUNTINGTON  
COUNTY DEPARTMENT OF HEALTH**

WHEREAS, the Huntington County Department of Health is under the oversight of the Board of Commissioners of Huntington County, Indiana; and

WHEREAS, Indiana Code 36-1-3-1 to 9, inclusive, grants certain home rule powers of Huntington County; and,

WHEREAS, it is the desire of the Board of Commissioners of Huntington County, Indiana, and the Department of Health of Huntington County, Indiana, to fix the permit fees for the office of the Huntington County Health Department.

NOW, THEREFORE, BE IT ORDAINED, by the Board of Commissioners of the County of Huntington, State of Indiana, that a Uniform Fee Schedule be established for the Huntington County Department of Health reading as follows:
