# AN ORDINANCE TO AMEND THE HUNTINGTON COUNTY OFFICIAL ZONING MAP

BE IT ORDAINED, BY THE Board of County Commissioners of Huntington County, Indiana, in a meeting duly assembled;

WHEREAS, the Huntington County Plan Commission considered an application filed by Virgyle H. Hougendobler to amend the Official Zoning Map as to certain real estate from A (Agriculture) & R2 (Residential) to GB (General Business) of the property located at 3856 W. 500N Huntington, IN 46750.

#### LEGAL DESCRIPTION:

A part of Tract 4 in the Reserve Ten Sections, Township 28 North, Range 9 East, more definitely located and described as follows, to wit:

Beginning at a iron pin on the South line of said Tract 4 at a point 1784.06 feet West of the Southeast corner thereof, thence continuing West along said South line 520.8 feet to an iron pin, thence North along a line parallel with the East line of said Tract 4 a distance of 666.8 feet to a wooden corner post, thence East a distance of 520.2 feet to an iron pipe, thence South a distance of 663.96 feet to the place of beginning, containing 7.95 acres of land, more or less.
