Whereas, pursuant to Indiana Code 3-11-1.5, the Board of Commissioners is required to modify the boundaries of precincts in Huntington County in order to comply with the directives of Indiana Law; and,

Whereas, certain changes have occurred with legislative districts and municipal boundaries in Huntington County requiring the need to revise and update the existing precinct boundaries in Huntington County and to file with the Indiana Election Commission updated Precinct Summary Statements and updated Precinct Boundary Maps.

Whereas, a draft Precinct Establishment Order, updated Precinct Summary Statements and updated Precinct Boundary Maps were submitted to the Indiana Election Commission and approved by the Commission by Order dated October 30, 2009, which Summary Statements and Precinct Boundary Maps are incorporated herein and are on file with the Huntington County Clerk Office.

Now therefore, be it ordered by the Board of Commissioners of Huntington County as follows:


Huntington County, Indiana, by and through its Board of Commissioners hereby


establishes voting precincts for the County as set forth in the Precinct Boundary Maps and Precinct Summary Statements made a part of this Order. Said Precinct Boundary Maps and Precinct Summary Statements shall be maintained by the Clerk of the Huntington Circuit Court.

This Order shall become effective upon approval of said precincts by either the Indiana Election Division, provided no objection is filed by a voter of the County by Noon 10 days after the publication of notice of the proposed precinct establishment order, or upon approval of the Indiana Election Commission after hearing on a timely objection filed by a voter of the County all pursuant to the provisions of IC 3-11-1.5

WHEREAS, pursuant to IC 3-11-1.5-14, the Board of County Commissioners of Huntington County submitted a proposed precinct establishment order to the Co-Directors of the Indiana Election Division;

WHEREAS, pursuant to IC 3-11-1.5-17, employees of the Indiana Election Division designated by the Co-Directors have examined the proposed precinct establishment order and determined that the proposed precinct establishment order complies with the standards set forth in IC 3-11-1.5; and

WHEREAS, pursuant to IC 3-11-1.5-17, the Office of Census Data has reviewed the proposed precinct establishment order and provided technical comments to the Co-Directors and the Co-Directors have examined the technical comments of the Office of Census Data;

IT IS THEREFORE ORDERED:

SECTION 1. The Co-Directors of the Indiana Election Division, in accordance with I.C. 3-11-1.5-18, find that the proposed precinct establishment order submitted by the Board of Commissioners of Huntington County to establish certain precincts in Huntington County comply with the standards set forth in IC 3-11-1.5 and, based upon this finding, hereby **APPROVE** the proposed precinct establishment order submitted by the Board of Commissioners of Huntington County for these precincts.

SECTION 2. A copy of the precinct summary statements (State Form 13332; IEC-8), legal descriptions and maps for each precinct approved under SECTION 1 are incorporated by reference in this ORDER.
