Synopsis: This Resolution, if adopted, would authorize advanced payment of up to \$1,400 to Custom Cast Stone to begin the Hawley Heights Pillar Cap Rehabilitation Project.

A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF HUNTINGTON, INDIANA AUTHORIZING ADVANCED PAYMENT

The Common Council ("Council") of the City of Huntington, Indiana ("City"), in meeting duly assembled and upon information deemed by it to be sufficient, finds as follows:

WHEREAS, on July 17, 2023, the City accepted a quote received from Custom Cast Stone (attached) to reconstruct pillar caps which marked the boundaries to the historic Hawley Heights Subdivision by creating scaled molds and cast stone replicas of the decorative terra cotta pillar tops; and

WHEREAS, Custom Cast Stone advises the City that it requires a 10% deposit to begin work; and

WHEREAS, the General Assembly recently amended IC 5-11-10-1.6 which now authorizes the Common Council to make payments in advance for goods and services prior to their delivery or completion; and

NOW, THEREFORE BE IT RESOLVED that, Council hereby authorizes an advanced payment to Custom Cast Stone of up to \$1,400.

BE IT FURTHER RESOLVED, this Resolution shall be effective immediately upon adoption.



 - H. Quotation is based upon information received and for quantities listed only.
 - I. Additional quantities or changes are subject to new quotation.
2. This quotation WILL constitute a contract only if signed, dated and returned.
 - A. Upon receipt of signed quotation, Custom Cast Stone, Inc. will assign a job number and customer can follow the STATUS via WiseWhere.
 - B. Shop drawings are authorized by signing the quotation where designated.
 - C. Upon approval of shop drawings and color, a signed SALES ORDER or customer purchase order must be received before production is authorized.
 - D. After signing the quotation and authorizing the shop drawing process, customer IS liable for cost related to said drawings, including labor and materials, should the job be cancelled. Fee is 5% of project quotation.
 - E. In order to properly complete shop and setting drawings, Custom Cast Stone must have access to digital copies of the elevations, floor plans, site plans, wall sections and details. This includes .dwg and .pdf formats. Any costs associated with obtaining will be passed along to customer.
