<u>SYNOPSIS</u>: This ordinance, if adopted, would appropriate sums of money for the purpose of defraying the expenses of the several departments of the City Government of the City of Huntington, Indiana, for the fiscal year beginning January 1, 2024 and ending December 31, 2024, including all outstanding claims and obligations and fixing a time when the same shall take effect.
