REGULAR SESSION OF THE COUNTY COUNCIL OF HUNTINGTON COUNTY INDIANA APRIL 25, 2022 COUNTY COUNCIL MEETING

The Huntington County Council met in regular session on the 25th day of April 2022, in the G.A.R. Room, at the Huntington County Courthouse, Huntington, Indiana, at 7:00 P.M. for considering all business brought before it pursuant to notice given to the Huntington Herald-Press on April 13, 2022.

Council Members present: Kendall Mickley, Kittie Keiffer, Keith Eller, Shane Bickel, Terry Miller, Peyton Pike, and John Stoeckley.

The meeting was called to order by President Kendall Mickley. Terry Miller gave the invocation, and led the Pledge of Allegiance.

ITEM 1: Kittie Keiffer made a motion to approve the minutes from the March 25, 2022, County Council meeting with a correction to the Community Corrections Committee reports section. Terry Miller seconded the motion, and the motion passed 7-0.

ITEM 2: On behalf of Sheriff Chris Newton, Auditor Jill Landrum requested a Transfer of Appropriation of \$640.00 in the Misdemeanant Fund 1175, from budget line 1175.44110.000.0000 Misc. Equipment to 1175.36200.000.0000 Service Contracts. Shane Bickel made a motion to approve this transfer. Keith Eller seconded, and the motion passed 7-0.

ITEM 3: DISCUSSION OF PROPOSED CHANGE TO THE 2022 WAGE AND SALARY ORDINANCE.

Terry Miller spoke on behalf of, IT Director Joakim Abrahamsson in regards to adding another full-time, Non-Exempt, IT Position.

ITEM 7: Kittie Keiffer made a motion to approve the Additional Appropriation of \$35,000.00 for the new PC Position in the General Fund budget line 1000.11510.000.0106 PC Tech. Terry Miller seconded and the motion passed 7-0.

ITEM 8: Health Officer Dr. Matt Pflieger requested a transfer of \$10,500.00 from the 8908 Immunization & Vaccines Fund, budget line 8908.24500.000.0000 Operating Supplies to 8908.44110.000.0000 Misc. Equipment. John Stoeckley made a motion to approve this transfer. Terry Miller seconded and the motion passed 7-0.

ITEM 9: Highway Superintendent Troy Hostetler requested a Decrease/Increase. Decreasing \$45,000.00 from the MVH Restricted 1173.27500.000.0531 Materials and increasing the MVH

1176.45300.000.0530 Software Computer. Peyton Pike made a motion to approve this request. Shane Bickel seconded and the motion passed 7-0.

ITEM 10: Director of Community Corrections Leslie Rentschler requested a transfer of \$1,010.52 in the Project Income Fund 1122 from budget line 1122.11108.000.9610 Field Officer to 1122.11336.000.9610 Surveillance Officer. Shane Bickel made a motion to approve this transfer. Terry Miller seconded and the motion passed 7-0.
