REGULAR SESSION OF THE COUNTY COUNCIL OF HUNTINGTON COUNTY INDIANA JANUARY 18, 2022 COUNTY COUNCIL MEETING

The Huntington County Council met in regular session on the 18th day of January 2021, in the G.A.R. Room, at the Huntington County Courthouse, Huntington, Indiana, at 7:00 P.M. for considering all business brought before it pursuant to notice given to the Huntington Herald-Press on Jan 05, 2022.

Council Members present: Kittie Keiffer, Terry Miller, Peyton Pike, Keith Eller, and John Stoeckley. Kendall Mickley and Shane Bickel tried to join the meeting via zoom; however, due to technical difficulties, they were not able to connect until after Item 6 on the Agenda. The meeting was led by Council Vice President Kittie Keiffer. Was 1-28-2022 Keith Eller opened the meeting with Prayer and the Pledge of Allegiance.

ITEM 1: Election of Council Officers: Keith Eller made a motion to reappoint Kendall Mickley as Council President, and Kittie Keiffer as Vice President. Terry Miller seconded and the motion passed 5-0.

Leslie discussed how the State made a change regarding any carryover money, and how unspent money will not be returned but applied to the grant award for the next year. In doing this, the State decided to rotate each year between two (2) Fund numbers. Due to this change, previously approved Wages & Salaries need to have a different Fund number for 2022.

- 1) The Fund # must be changed from 9318 to 9316 and the Location # must be changed from 0000 to 9610 for employees no changes of amounts. John Stoeckley made a motion to approve this changes. Peyton Pike seconded and the motion passed 7-0 with Kendall and Shane approving by roll call.
- 2) The Fund # must be changed from 9328 to 9316 and the Location # must be changed from 0000 to 9630 for positions in Residential Work Release no changes to amounts.
