The siren has since been repaired and is now operational, thanks to Heartland REMC, which removed and reinstalled it at no cost.

Deputy Director, Fuller suggested acquiring a new siren to replace the outdated Bippus Siren. EMA has funds available to purchase the new siren, which, along with installation, will cost \$13,774.00.
