

## REGULAR MEETING COMMON COUNCIL – May 13, 2025

The Common Council of the City of Huntington met on the 13<sup>th</sup> day of May 2025, at 7:00 p.m., in accordance with all applicable requirements and notice.

**INVOCATION:** Associate Pastor Rob Jones, Central Christian Church, gave the invocation.

**CALL TO ORDER:** Mayor Strick called the regular meeting of the Common Council to order.

**ROLL CALL:** Common Council Members present: Dwight Brautigam, Charles Chapman, PJ Felton, Dave Funk, Todd Johnson, Paul Pike, and Andrew Rensberger.

**APPROVAL OF PREVIOUS MINUTES:** Council Member Brautigam moved to approve Council's April 29, 2025, regular meeting minutes as presented, seconded by Council Member Johnson. Motion passed 7-0. Minutes signed.

**REPORTS FROM COMMITTEES, BOARDS, OR COMMISSIONS:** Council Member Brautigam reported on the committee that will pick a construction manager for the City Building Renovations. Emma Working and the officers of That Viking Thing presented their 2025 Project of game (GaGa Ball and 9-Square) improvements to General Slack Park including how the two recreational games will be built, the rules of the games, and the cost of construction. They stayed within the budget and as a group, they will construct the games on May 23, 2025. No other reports were given.

**PETITIONS OR COMMENTS FROM CITIZENS:** Andrew Avery, Shive Hattery, presented the new Fire Station 1 design that will be located on Flaxmill Road. The timeline for the next two years and the cost estimate between \$9 and \$13 million. The cost of the project will be better known once bids are received in October. Council Members questions were asked and answered.
