#### **ORDINANCE 10-C-25**

Synopsis: This ordinance, if adopted, would vacate an alley right-of-way located North of Joe Street, East of Glenwood Alley (private), South of Beard Street and West of the North-South alley between Cycle Avenue and Briant Street (known as Tanglewood Alley); in Wright & Amiss Subdivision of the City of Huntington, Huntington County, Indiana.

#### AN ORDINANCE VACATING A RIGHT-OF-WAY WITHIN THE CITY OF HUNTINGTON, INDIANA

WHEREAS, on the 24<sup>th</sup> day of April 2025, Angel White on behalf of Huntington Mobile Estates MHC, LLC filed a petition to vacate a right-of-way, located within the City of Huntington, Indiana and more particularly described as follows:

The 15.85 foot wide alley right-of-way, running East-West and located North of Joe Street, East of Glenwood Alley (private), South of Beard Street and West of the North-South alley between Cycle Avenue and Briant Street (known as Tanglewood Alley); in Wright & Amiss Subdivision of the City of Huntington, Huntington County, Indiana; more particularly described as follows:

Beginning at the Southeast corner of Lot Number 70 in the Plat of Wright & Amiss Subdivision as recorded in the Huntington County Indiana Recorder's Office; thence Southerly across the subject 15.85 foot alley running East-West to the Northeast corner of Lot No. 87 in said Subdivision; thence Westerly along the North line of Lot Nos. 87, 88, and 89, a distance of 150 feet to the Northwest corner of said Lot No 89; thence Northerly across the subject 15.85 foot alley to the Southwest corner of Lot No. 68; thence Easterly 150 feet to the Point of Beginning. Containing 2,377.5 square feet more or less.

WHEREAS, a map marking the proposed portion of the right-of-way to be vacated is attached and incorporated herein as Exhibit "A";

WHEREAS, appropriate notice has been given, and a public hearing has been held within thirty (30) days after the filing of that petition, all in the manner provided by law; and

WHEREAS, no remonstrances to the proposed vacation have been filed or raised and the matter is now properly before the Council for action, all pursuant to applicable law.

## ORDINANCE 10-C-25

NOW THEREFORE, THIS COUNCIL FINDS that the vacation of the right-of-way will not be a detriment to the health, safety, and general welfare of the citizens of the City of Huntington, Indiana, and that such vacation will not:

- 1. make access to any other parcels of land impossible;
- 2. eliminate the public's access to a church, school or other public building or place;
- 3. hinder the growth or orderly development of the City of Huntington, Indiana;
- 4. hinder the use of any street, alley or public way;
- 5. be of any detriment to the health, safety and general welfare of the citizens of the City of Huntington, Indiana.

NOW, THEREFORE, BE IT ORDAINED that the right-of-way as described above are hereby vacated.

BE IT FURTHER ORDAINED that utility easement rights are reserved over this vacated alley.

BE IT FINALLY ORDAINED that this ordinance shall be in full force and effect following its adoption and in accordance with applicable law and the Clerk-Treasurer is directed to furnish a copy of this Ordinance to the County Auditor and County Recorder for recording as provided by applicable law, which shall be conclusive evidence of the vacation of the right-of-way as described in this Ordinance.
