# IN THE MATTER OF CERTIFICATE)

## 2025 Covered Bridge Certification

Tom Wall made a motion to sign the 2025 Covered Bridge Certification stating that Huntington County does not have any covered bridges per IC code 8-14-1-10. Terry Stoffel second, and the motion passed unanimously with a 3-0 vote.

## IN THE MATTER OF BIDS)

#### WRHCF Grant Project for O'Donnell Center

The Commissioners received and opened four sealed bids for the WRHCF Grant Project at the O'Donnell Center. The first bid, totaling \$97,420.00 for masonry work, was submitted by Slatile Roofing and Sheet Metal. The second bid, also for masonry, came from The Hagerman Group in the amount of \$46,115.00. The third bid, submitted by O'Neil Glass, was for window work and totaled \$42,300.00. The fourth bid for windows was also from Slatile Roofing and Sheet Metal in the amount of \$45,538.00. Terry Stoffel made a motion to take the bids under advisement. Tom Wall seconded the motion, which passed unanimously with a 3-0 vote.

## IN THE MATTER OF DISCUSSION)

#### Skatepark Fundraising

Lucas Juillerat and Christina Knecht presented their skatepark fundraising initiative, W.H.E.E.L.S. (Working in Huntington to Elevate & Energize Local Skaters), to the Commissioners. Lucas has a personal connection to the project, having been an avid skater for many years. Their goal is to raise \$50,000 from people within the community. During the presentation, Commissioner Stoffel inquired about plans for security measures, including the installation of cameras and how they intend to prevent vandalism or illegal activity at the park. While there are currently no plans for installing security cameras, Commissioner Stoffel recommended that they consider budgeting for them.

#### **Certifications and Assurances**

Tom Wall made a motion to approve the 2025 Certifications and Assurances for Huntington County Council on Aging. Terry Stoffel seconded, and the motion passed unanimously with a 3-0 vote.

# IN THE MATTER OF DISCUSSION)

#### **Huntington Main Street**

Sharon Metzger, representing Huntington Main Street, approached the Commissioners to request funding for downtown Huntington development. The organization is seeking \$30,000 in support. The Commissioners responded by stating they would review the budget to determine if any funds could be allocated for this purpose.

#### Sprout by 5

Courtney Bonbrake, representing Sprout by 5, addressed the Commissioners to request funding to support efforts in expanding childcare options in Huntington County. The organization requested \$25,000 annually over the next three years, totaling \$75,000. Tom Wall made a motion to allocate a total of \$75,000 from CEDIT Project 4 funds over the years 2026, 2027, and 2028 to support Sprout by 5. Terry Stoffel seconded, and the motion passed unanimously with a 3-0 vote.
