

ORDINANCE 20-C-25

Synopsis: This ordinance, if adopted, would amend Ordinance 9-C-24, an ordinance establishing a designated outdoor refreshment area (DORA) by adding and removing certain entities from the list of designated permittees.

AN ORDINANCE AMENDING ORDINANCE 9-C-24 (DORA) OF THE CITY OF HUNTINGTON, INDIANA

WHEREAS, on October 8, 2024, the Common Council of the City of Huntington, Indiana adopted Ordinance 9-C-24 establishing a designated outdoor refreshment area (DORA); and

WHEREAS, in accordance with requests and applications for inclusion as a designated permittee, City Ordinance 9-C-24 should be amended to include two additional designated permittees and to remove one existing designated permittee; and

NOW, THEREFORE, BE IT ORDAINED, by the Common Council of the City of Huntington, Indiana in meeting duly assembled based on information deemed by Council to be sufficient, that Ordinance 9-C-24 of the City of Huntington, Indiana be and is hereby amended by amending the list of designated permittees in Paragraph 7 of that Ordinance 9-C-24 as follows:

Add: Blue Collar, Inc. d/b/a Blue Collar Bar
Ghost, LLC, d/b/a Legends Sports Bar

Remove: TOJI, Inc., d/b/a Legends Sports Bar

BE IT FURTHER ORDAINED, that Exhibit A of Ordinance 9-C-24 is hereby amended to include the newly designated permittees and is attached hereto and incorporated herein by reference as Exhibit A.

BE IT FURTHER ORDAINED, Ordinance 9-C-24 is only amended by inclusion or removal of the provisions above, the remaining portions of Ordinance 9-C-24 shall remain unchanged.

BE IT FINALLY ORDAINED that this Ordinance shall be in full force and effect following its adoption, subject to submission to and approval of ATC, and otherwise in accordance with applicable law.
