**BPW&S RESOLUTION 2026-2**

**A RESOLUTION OF THE BOARD OF PUBLIC WORKS AND SAFETY OF THE CITY OF HUNTINGTON, INDIANA RELATING TO THE SINGLE SOURCE PURCHASE OF A FIRE POLE**

The Board of Public Works and Safety (“Board”) of the City of Huntington, Indiana (“City”), in meeting duly assembled, after considering information deemed by it to be sufficient, finds:

**WHEREAS**, the City is constructing a new northside fire station, together with all necessary appurtenances, related improvements, and equipment; and

**WHEREAS**, the City has been informed by its project general contractor that there is only a single source, McIntire Brass Works, Inc., for the fire pole needed for construction; and

**WHEREAS**, on January 28, 2026, the City received a quote from McIntire Brass Works, Inc. for \$50,950 which quote is attached and incorporated as Exhibit A; and

**WHEREAS**, on February 24, 2026 the Common Council of the City of Huntington approved Resolution 3-R-26 authorizing an advanced payment to McIntire Brass Works, Inc. for not more than \$16,983.33; and

**NOW, THEREFORE, BE IT RESOLVED**, by this Board, as follows:

1. McIntire Brass Works, Inc. is the single source provider of the fire pole needed for the construction of the City’s new fire station; and
2. The City’s Common Council has adopted Resolution 3-R-26 authorizing advanced payment to McIntire Brass Works, Inc. of not more than \$16,983.33.
3. In accordance with IC 5-22-10-13 and Exhibit A, the Board approves the purchase, including the initial advanced payment, of a fire pole from McIntire Brass Works, Inc.
