<u>Synopsis</u>: This ordinance, if adopted, would amend the Code of Ordinances of the City of Huntington, Indiana by amending Sections 95.09 and 95.10 to increase the fees charged for trash collection and recycling in order to comply with new contractual requirements.

ORDINANCE 27-C-22

AN ORDINANCE AMENDING SECTIONS 95.09 AND 95.10 OF THE CODE OF ORDINANCES OF THE CITY OF HUNTINGTON, INDIANA

WHEREAS, the Common Council of the City of Huntington, Indiana ("Council") has been advised that the current contracts for trash collection and recycling end December 31, 2022; and

WHEREAS, Council has also been advised of the results of the City's recent bid for trash collection and recycling and that the fees for such services should be increased in conjunction with the new contract; and

NOW, THEREFORE, BE IT ORDAINED THAT, Council, in meeting duly assembled, after consideration and deliberation deemed by it to be sufficient, hereby amends the Code of Ordinances of the City of Huntington by amending the fees charged in Sections 95.09 and 95.10 respectively as follows:
