
WHEREAS, the said Rental Agreement provides for the terms and conditions for the use of the facility, as well as for the payment of a space rental fee.


WHEREAS, the said Rental Agreement provides for the terms and conditions for the use of the facility, as well as for the payment of a space rental fee.
