A. Vision and Programming

- 1. Discussed City's vision for the Park
- 2. Identified current uses, desired improvements and priorities.
 - a. Sports: Current sport uses include Tennis, Pickle Ball, Disc Golf and Basketball. Separate facilities are desired for Pickleball as it is damaging tennis court equipment. All sports elements may be relocated as needed. Additionally, if space is needed for relocations, ball field is no longer in use as the Hier's Park facility is being utilized. Would like to renovate basketball court.
 - b. Gardens: Would like to limit maintenance. In other areas, the city would like to start tree plantings for eventual replacement of mature and storm damaged trees. Would be interested in using strategic plantings to delineate boundaries of property, but maintain openness and visibility.
 - c. Memorial: City wants to take some time to focus on the "Memorial" part. They are working on getting updated plane and tank. Relocation was originally slated for the area near tennis courts in the 2010 5-year parks master plan.
 - d. Ponds/Drainage: Southern pond has existing leak and is being filled from the west. Stagnancy of ponds is a high priority concern. Ponds were former fish hatchery area. Erosion along channels and outlets is a concern. Clean up banks of ponds and creek. May include new options for bank armor and native plantings. Bridges require replacement for accessibility and safety.
 - e. Trails: Would prefer one quality trail over quantity. Local cross country teams use wooded

trails for training/meets and would like them to remain. Want connection to Sunken Gardens.

- f. Parking: The City is interested in improving parking near the gazebo. Current informal parking is located along Memorial Lane.
- g. Accessibility (ADA): Items indentified in the 2012 Self-Evaluation and Transition Plan should be included in future park development.
- h. Other items of interest: Amphitheater, raised beds and canopy structures similar to Kreager Park in Fort Wayne, restoration of fountains, interpretive signage, use of forest green and black trim on any proposed structures
- 3. Discussed level of maintenance (current and future) and known issues.
 - a. Mayor has recently developed Community Engagement position. They will be looking for help from community volunteer groups in maintenance of parks.
 - b. Limit maintenance by providing less space for planting areas, but maintaining a higher quality where included.
- 4. Local historical information available (Indiana Room, Historic Review Board).
 - a. DLZ is reviewing the historical information available at the Library to determine specific areas of historical significance.
 - b. Confirmed that portions of the rockwork within the park are WPA projects in 1937. This should be considered when impacting these areas.
- 5. Limits confirmed per contract scope. Parks property on west side of drive may be used conceptually for relocation of sports areas as needed, but will not be studied.

B. Funding / Historical Impacts

- Discussed impact of different types of funding on historical documentation / approval requirements.
 Federal funding would invoke provisions of 106 of the National Historic Preservation Act.
 Transportation Enhancement funding would invoke Section 4F. Local funding would only require local Historic Review Board approval. It is assumed that any improvements proposed would be respectful of historically significant items, and have a minor effect in the best interest of the property.
- 2. City will confirm that Land and Water Conservation Funds have not been used in the Park in the past.
- 3. Grant application for addition of Park to National Registry of Historical Places is still underway.



C. Next Steps

- 1. Conducted field inventory and site analysis on 11/25/2013.
- 2. Develop preliminary Conceptual Park Plan (December).
- 3. Present Plan to City, including opinion of probable construction cost and phasing. (Schedule meeting week of 1/6/2014)
- 4. Finalize Conceptual Park Plan and develop various renderings for marketing purposes. (1/31/2014)

A. Presented Site Analysis

B. Presented Preliminary Conceptual Park Plan

- 1. New or Relocated Improvements
 - a. Tennis/Pickleball Complex City liked location and confirmed number of courts shown are acceptable.
 - b. Basketball Location may better serve adjacent higher density residential and good proximity to newly renovated shelter.
 - c. Amphitheater City feels this would be a large attraction and is not a feature currently in the park system.
 - d. Veterans Memorial Plans are underway to get the existing plane rehabilitated. Discussion was held regarding if this should be done and reset in current place, or if this should be placed in the proposed location. If replaced where currently located, it would need to be placed on raised platform to prevent kids from playing on it. Consensus was reached that a single move of the plan was likely to be viewed more positively and be more cost effective. This area is envisioned for use for ceremonies, etc and to honor all branches of the military. The City likes the visibility of the proposed location.
 - e. Picnic Area is a good addition.
 - The City would like the park to have lighting for safety purposes. Lighting/electrical will be added to the plan and estimate to reflect appropriate levels of lighting for a park using decorative fixtures.

g. Disc golf course should not be impacted by any of the proposed improvements.

2. Renovation

- a. Paths City agreed that these are major use areas, but would like to see this occur as part of the second phase of improvements. Also noted that the plan should address bike route through (or adjacent to) the park. It was discussed that bike traffic could enter the park trail at St. Felix, use multi-use trail and park roadway to reach Memorial Lane, and then follow future dedicated bike lane along Bartlett to reach either West Park drive or the connecting trail from the south parking lot to Dimond Street. Larger vision includes bike route from Schenkel's Dairy (near intersection of Flaxmill and US 24) to Sunken Gardens.
- b. Fountains and Gardens Discussed current state of each fountain area. The City would like to see the fountain at Waltonian Gardens rehabilitated as they envision this area for use in gatherings, weddings, etc as in past. The Arborial garden presents more challenges to restore. The City agreed in light of this and the maintenance required for another fountain that they would like to see this converted to a focal point planting area maintaining the stone work at the perimeter.
- c. Bridges Discussed the various options for rehabilitation, removal, and expansion of the bridges. The City would like to see the northernmost bridge widened and the other removed at the Waltonian Gardens. On the south end near the tennis courts, both bridges should be shown as widened. The remaining bridges will be assumed to have a more decorative railing system.

C. Phasing

- 1. Phase I will include all improvements south of the Lower Pond berm, including the new memorial space, relocation of the plane, amphitheater, picnic area, and bridges, as well as the new tennis/paddleball complex and parking, and the basketball courts.
- 2. Phase II will include all improvements to the Upper and Lower ponds and creek.
- 3. Phase III (or concurrent with Phase II) will include all other work north of the Lower Pond berm, including the Waltonian Garden, trails, new parking area at the Gazebo, and bridges.

D. Next Steps

- 1. DLZ civil engineer to make site visit to finish review of drainage structures, erosion and pond issues when weather allows.
- 2. Finalize Conceptual Park Plan document.
- 3. Prepare final opinion of probable construction cost and outline potential phasing plan.



4. Develop perspective or section renderings for marketing purposes. Areas to be addressed will include the Waltonian Garden, the tennis/paddleball complex, the amphitheater and the Memorial.



- Transfer platform is too high and height of risers on transfer steps is not equal and steps are not level.
- Restrooms have non-compliant signage, sinks that are too high, pipes under the sinks are not insulated, space on the narrow side of the toilet is excessive, rear grab bars are not properly installed, and coat hooks are too high.
- Memorial Park/Sunken Gardens/ Shakespeare Gardens – Memorial Park is one of the largest parks in the City and houses a number of programs. Included at Memorial Park are Waltonian Gardens, Shakespeare Gardens, and Sunken Gardens. Sunken Gardens is registered on the National Register of Historic Places. The park a number of barriers and/or noncompliant items, including:
 - The parking lot at the main entrance off Park Driver has very faint pavement markings, an access aisle that is too narrow, and no signage at the barrier-free parking. The curb ramp has a lip at the gutter line that exceeds ½".
 - The parking lot near the stone pavilion on the west side of the park has no barrier-free parking or signage provided.
 - The walks in the park have sections that exceed 5% running slope, sediment deposited on the walk, surfaces that are in poor condition, has gaps at transitions in material, have surface level changes and cracking with gaps, surfaces that are not compliant (slippery when wet), areas with excessive cross slope, areas that are too narrow, segments over 200' in length with no passing spaces, sections that include stairs, and sections with materials that have excessive gaps (bricks).
 - The stairs accessing Waltonian Gardens have risers that are not uniform height, are not slip resistant material (stone), and have handrails that are not compliant.
 - Drinking fountains provided in the park are single units (not hi-lo), don't have adequate underclearance and have bubblers that are too high for wheelchair users, are not located on level ground,

- and/or require excessive force to operate.
- Restroom doors have surface level change at the thresholds. The restrooms are not located on an accessible route, do not have compliant signage, do not have insulation on pipes sinks, have mirrors, switches, and electrical outlets that are too high, barrier-free stalls do not have handles on the outside of the door, grab bars are too short, toilet paper dispensers block the grab bar, and coat hooks that are too high.
- There are no accessible routes to grills, horseshoe area, tennis courts, basketball area, or baseball/softball field. There are no wheelchair spaces provide in bench areas at the baseball field.
- There are no accessible routes into the play area or to any ground level play components, the surfacing material is not compliant, no level clear area is provided adjacent to play components, and the turning space on the play structure is less than 60" diameter.
- The shelter near the play area has electrical outlets that are blocked by picnic tables and is too high. The stone shelter has a concrete floor with extensive cracking that has separations and level changes.
- Sunken Gardens has no compliant parking, the walk/ramp from the parking area has excessive slopes and is not a compliant surface, no handrails are present in the tunnel, all sets of steps and handrails have numerous compliance issues, the wooden sitting area on the intermediate level has no accessible route connecting it, and the area is wood (slippery when wet).
- Shakespeare Gardens has walks with areas of excessive running slope and cross slope, surface level changes, and landings that are not level, picnic table sin the shelter block the PAR through, access to the end of the picnic tables for wheelchair is not available in the current layout, picnic table blocks access to the

electrical outlet, and the light switch in the shelter is too high.

- Riverside Park has no facilities or programs so is compliant
- Yeoman Park/Hayes-Lemmerz Skate Park/Erie Park – houses a number of programs and has a number of barriers and/or non-compliant items, including:
 - The site has three parking areas, all of which lack van-accessible and barrierfree parking and signage. North parking lot is gravel and provides no compliant surface for barrier-free parking spaces.
 - Areas of sidewalk have excessive slopes and surface level changes.
 - The drinking fountain near the skate park has several compliance issues.
 - A step is required to access the restrooms from the adjacent PAR, an excessive level change is present at the door, and the door has no handles on the pull side.
 - Bleachers at the ball field have no wheelchair spaces or companion seating and are not located on an accessible route.
 - Clear space around all sides of picnic tables is not available (tables are attached) and they block the clear space at the grill. Underclearance at picnic tables is too low for wheelchair user.
 - Clear space adjacent to benches is not provided and no accessible route is provided to the skate park viewing area, baseball/softball diamond, soccer fields, and basketball courts. No accessible route connects both sides of sports fields and no wheelchair spaces are provided in baseball player bench areas.
 - There are no accessible routes into the play area or to any ground level play components, the surfacing material is not compliant, no level clear area is provided adjacent to play components, and the transfer platform it too high.
 - Restrooms do not have compliant signs, have inadequate sink underclearance height and depth, pipes under the sinks are not insulated, mirrors and light switches are too high, urinal lips are too high, barrier-free stalls have no handles

- on the inside, stall widths are too narrow, toilet flush controls are on the narrow side of the toilet, toilet paper dispensers are not located properly, and grab bars are not properly installed.
- Homier Park houses primarily baseball/softball games and support programs and has a number of barriers and/or non-compliant items, including:
 - The parking lot is not a compliant surface. Markings are not obvious and access aisles are not properly marked to prevent parking. Signage does not include any van-accessible spaces and mounting height of signs is too low.
 - o Walks are of various materials including compacted limestone that is generally compliant but requires maintenance, surface level changes exist at the interface with concrete, areas of the PAR near the restroom breezeway have concrete width less than 36", three concession window shelves, drinking fountain, and air conditioner protrude, and drinking fountain is not hi-lo.
 - Grandstands at all four fields lack wheelchair spaces and companion seating. No wheelchair spaces are provided in player seating areas.
 - Picnic tables have insufficient knee space depth.
 - Restrooms excessively have high threshold, signage is not compliant, accessible sinks do not have pipes insulated, mirrors, light switches, and electrical outlets are too high, barrierfree stall does not have handles on the inside of the door, toilet is too far from the near wall, flush controls are on the narrow side of the toilet, toilet paper dispenser is not located properly, grab bars are mounted too high, too short, and/or are not centered properly, and coat hooks are too high.
- City Parking Lots the City owns property for public parking outside the public ROW in seven different lots. All have various issues, barriers, and/or non-compliant items, including:
 - Lack of barrier-free parking
 - Lack of van-accessible parking
