

REGULAR SESSION & BUDGET HEARINGS OF THE COUNTY COUNCIL
OF HUNTINGTON COUNTY INDIANA
AUGUST 21, 22, 2017

The Huntington County Council met in regular session this 21st & 22nd days of August, 2017, in the G.A.R. Room of the Huntington County Courthouse, Huntington, Indiana at 6:00 P.M for the purpose of considering all business brought before it pursuant to notice given to the Huntington Herald Press, August 11, 2017.

Council Members present: Kendall Mickley, Terry Miller, Todd Landrum, Don Davenriner, Ron Kline & Shane Bickel. Absent: Keith Eller both days.

The meeting was opened with prayer by Don Davenriner and the Pledge of Allegiance.

Binding Review:

Solid Waste Management District, Scott Husband presented his budget for review for the 2018 budget year. The Total budget estimate is \$378,228.00. Todd Landrum made a motion to accept the budget review for 2018. Terry Miller seconded and the motion passed 6-0.

ITEM: 1 Don Davenriner made a motion to approve the July 17, 2017 County Council minutes. Todd Landrum seconded and the motion passed 6-0.

ITEM: 2 A request for an appropriation of special funds in the 4601 Bond Construction fund for \$4,500.00 in the 4601-000-40.0001 issuance costs for unforeseen expenses. Shane Bickel made a motion to approve this request. Ron Kline seconded and the motion passed 6-0.

ITEM: 3 Robert Jeffers is requesting an appropriation of special funds in the L.E.P.C fund for \$5,600.00 in the 1152-361-20.0052 misc. equipment line for the purchase of 2 gas meters. Todd Landrum made a motion to approve this request. Terry Miller seconded and the motion passed 6-0.

ITEM: 4 Dispatch Director Melissa Christman is requesting to transfer:
\$280.00 from the 1000-382-10.0027 certification pays to 1000-382-20.0011 office supplies,
\$500.00 from the 1000-382-10.0016 dispatchers pays to 1000-382-20.0011 office supplies,
\$2,810.00 from the 1000-382-10.0016 dispatchers pays to 1000-382-30.0025 travel. Terry Miller made a motion to approve these transfers. Don Davenriner seconded and the motion passed 6-0.

ITEM: 5 IT Director Matt Taylor requested an appropriation of special funds in the IT Services fund for \$124,000.00 out of the 4016-999-20.0041 mobile data line, to pay the next Spillman payment. Todd Landrum made a motion to approve this request. Terry Miller seconded and the motion passed 6-0.

Terry Miller made a motion that Council review estimated property tax levy limits and reductions due to circuit breaker for each taxing unit, and the recommendation is that they abide by these numbers. Don Davenriner seconded and the motion passed 6-0.
