# Huntington County Public Dispatch - Update on Equipment and Services

They would like to move forward with entering into a lease with Motorola Solutions to provide, in part, hardware, software and services. Specifically, Motorola would provide five MCC 7500 Dispatch Console operator positions, a GGM 8000 Site Gateway, an Archiving Interface Server, as well as the implementation and warranty services needed to support them.

Rob Miller asked that Melissa and Matt set up a meeting with J & K Communications to discuss the issues that they are having with their current system and to discuss relinquishing the current agreement with them.

Tom Wall requested that Motorola Solutions attend the next Commissioners' meeting to discuss what services they will provide to the County and to answer any questions that the Commissioners may have.

## **Huntington County Public Safety Dispatch**

Melissa spoke about the details of the grant and indicated that the Federal 911 Grant program requires a 40 percent match of the cost of the proposed project.

Rob Miller seconded and the motion passed 3-0.

## **Helping Hands Community Garden**

Becky Arnett, Program Assistant with Purdue Extension, appeared before the Commissioners to request moving the Helping Hands Community Garden from its current location on Viking Lane at Huntington North High School to the Huntington County Annex Building located on South Jefferson Street. Becky indicated that she believes that the South Jefferson Street location would better fit the needs of the garden in that it is easier access for volunteer workers, along with better access to water. Becky also believes it would be a more convenient location for the Purdue Extension staff to monitor and care for the garden. Becky spoke about doing soil samples in that area to determine if it was a good location for the garden, along with discussing the possibility of raised garden beds.

By consensus, the Commissioners agreed that Becky could move forward with obtaining various soil samples of the Huntington County Annex Building location on South Jefferson Street to determine if it was a good location for the proposed garden, along with looking into the cost of building raised beds and to consider exactly where on the property would be the best location to put the garden.

Change Order No. 005 – Huntington County Courthouse Masonry Phase 2, Reroof and Restrooms Midwest Maintenance, Inc. presented Change Order No. 005 for the Huntington County Courthouse Masonry Phase 2, Reroof and Restrooms between Huntington County, DLZ Indiana, LLC and Midwest Maintenance, Inc. The change order calls for a total increase in the amount of \$38,770.19, and consists of: Item #1 – Removal and disposal of shingles, plywood found on dormers under existing EPDM roofing membrane, installation of additional ISO board and adhesive and additional crane equipment time for material, \$25,713.56; and, Item #2 – Installation of additional wood blocking and metal fascia over existing limestone edge cap due to limestone being too deteriorated to accept original termination bar as originally detailed, \$13,056.63.

Tom Wall made a motion to approve Change Order No. 005 for the Huntington County Courthouse Masonry Phase 2, Reroof and Restrooms between Huntington County, DLZ Indiana, LLC and Midwest Maintenance for an increase in the total amount of \$38,770.19, to be paid of the construction bond fund. If there is not adequate money in that fund to pay for the increase then it will be paid out of the Cumulative Courthouse fund. Rob Miller seconded and the motion passed 3-0.

# Closed Huntington County Landfill, Huntington County, Indiana

Glen Howard, Senior Project Manager for SES Environmental submitted a letter to the Commissioners citing that as part of a continuing corrective action to reduce leachate at the closed landfill, construction of a perimeter drain is required per the Indiana Department of Environmental Management. Glen indicated that on September 17, 2018 a Request for Quote (RFQ) for perimeter drain construction was issued to several contractors. SES received three bids. Glen provided a bid tabulation sheet, along with the three contractor bids. Based on bid results and IDEM requirements, Glen submitted an itemized budget amount that is required to complete the project.

After reviewing the paperwork, the Commissioners requested that Glen be contacted to set up a time to come to the next Commissioners' meeting to further discuss the closed landfill project.
