

REGULAR MEETING COMMON COUNCIL – January 14, 2020

The Common Council of the City of Huntington met in Council Chambers, Third Floor, City Building, Huntington, Indiana, on the 14th day of January 2020, at 7:00 p.m., in regular session and in accordance with all applicable requirements and notice.

Council Member Chapman made a **motion to approve on second and final reading Ordinance 1-C-20:** "An Ordinance Amending 8-C-19: An Ordinance Fixing Salaries of Appointed Officers of the City of Huntington, Indiana, From and After December 22, 2019, Through the Pay Period Ending December 19, 2020; and Hourly Employees of the City of Huntington, Indiana, From and After December 15, 2019, Through the Pay Period Ending December 12, 2020 (2020 Salary Ordinance)", seconded by Council Member Felton. Motion passed 6-0. Ordinance signed.

MISCELLANEOUS:




ADJOURNMENT:


Council Member Chapman made a motion to adjourn, seconded by Council Member Marshall. Motion passed 6-0.






