

REGULAR MEETING COMMON COUNCIL – February 11, 2020

The Common Council of the City of Huntington met in Council Chambers, Third Floor, City Building, Huntington, Indiana, on the 11th day of February 2020, at 7:00 p.m., in regular session and in accordance with all applicable requirements and notice.

INVOCATION: Pastor Micah Mobley of Faith Chapel Church of God gave the invocation.

CALL TO ORDER: Mayor Strick called the regular meeting of the Common Council to order.

ROLL CALL: Common Council Members present: Joe Blomeke, Charles Chapman, PJ Felton, Dave Funk, Seth Marshall, Jerry Meehan Jr., and Paul Pike.

PUBLIC HEARING: Mayor Strick opened the public hearing for Resolution 1-R-20: “Preliminary Resolution Designating Economic Revitalization Areas for 2020 and 2021”. City Attorney Hartburg addressed Council and explained the process of designating economic revitalization areas and how that process can streamline consideration of tax abatement requests. With no one else wishing to speak, Mayor Strick closed the public hearing.






MISCELLANEOUS:
